EU Framework

Union 2030 energy and climate framework



Union's binding target to cut emissions by at least 40 % below 1990 levels by 2030.

DIRECTIVE (EU) 2018/2001 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 11 December 2018 on the promotion of the use of energy from renewable sources (RED II)



- Share of energy from renewable sources in the Union's gross final consumption of energy in 2030: 32 %.
- Share of renewable energy within the final consumption of energy in the transport sector by 2030: 14 %.
- Contribution of advanced biofuels and biogas as a share of final consumption of energy in the transport sector in 2030: 3,5 %.



Gross electricity generation (GWh)








Biofuels and biogas for transport (%)



- Promotion of renewable energies in industry.
 - ✓ Focus on thermal uses, including biomass and biogas.
- Framework for the development of renewable energies for thermal uses.
 - ✓ Including biomass and biogas.
- Biofuels for transport.
 - ✓ Biofuels consumption mandate.
 - ✓ Aid for investment in advanced biofuels plants.
 - ✓ Specific targets for aviation.
- Promotion of renewable gases.
 - ✓ Including biogas and biomethane.
- Specific programmes for the use of biomass.
 - ✓ Legislative and economic policies.
- GHG emissions reduction in waste management.
 - ✓ Including biogas and biomethane production.





Spain – Long-term decarbonisation strategy 2050

- Synergies between forest management and bioenergy production.
 - ✓ Decarbonisation.
 - ✓ Forest fire prevention.
 - ✓ Rural development.
- Sectoral decarbonisation.
 - ✓ Transport: contribution of biofuels and biogas for transport.
 - ✓ Renewable gases: including biogas and biomethane.
 - ✓ Agricultural: biogas and fertilisers production.
 - ✓ Municipal waste and waste water: biogas and biomethane production.
- Under development:
 - ✓ Biogas roadmap.
